

Terms and Conditions

These terms and conditions ("**Terms**") apply to the Bestway & Batchelors Supercash Promotion (the "**Promotion**"). By participating in the Promotion, you will be legally bound by these Terms.

If there is a conflict in these Terms with any other terms whatsoever attached to any other advertising material in respect of the Promotion, these conditions will take precedence.

The Promoter, Bestway & the Fulfilment Provider

1. Premier Foods Group Limited of Premier House, Centrium Business Park Griffiths Way, St. Albans, United Kingdom, AL1 2RE is the "**Promoter**".
2. Bestway Wholesale Limited of 2 Abbey Road, London, NW10 7BW is "**Bestway**" and will be responsible for administering the Promotion.
3. Altavia UK of Mercury House, 8 Sandy Way, Grange Park, Northampton, United Kingdom, NN4 5EJ is the "**Fulfilment Provider**" and is responsible for arranging the fulfilment of the prize

Eligibility

4. The Promotion is open to residents of Great Britain (England, Wales and Scotland) aged 18 or over who have an active account with Bestway Wholesale Limited. Internet access is required to enter. The Promotion is not open to employees, contractors, representatives, agents, officers or directors of the Promoter, its parent companies, subsidiaries, affiliates, marketing agencies, or to any of their immediate family members or persons living in the same household, whether or not related, or to anyone else professionally connected with the Promotion.
5. The Promoter reserves the right to verify the eligibility of any participant or claimant of a prize. The Promoter may require such information as it considers reasonably necessary for this purpose, which may include proof of purchase, identity, age, residency and address. How to Enter

The period from the Opening Time and ending at the Closing Time is the “**Promotion Period**”. All entries into the Promotion online must be received by the end of the Promotional Period. The Promoter accepts no responsibility for entries that are lost, delayed, incomplete, corrupted or not received by the end of the Promotional Period for any reason. Proof of submission shall not be deemed to be proof of receipt
7. To enter, purchase a minimum of five (5) cases of any Qualifying Products in a Bestway depot or online during the Promotion Period. Qualifying purchases will be validated by Bestway. Entry is automatic; no form submission is required.

Restrictions on entry

1. There is a limit of one entry per Qualifying Purchase.
2. Participants who seek to enter more than this limit may be disqualified. Entries generated by script, macro, mechanical or other automated means are prohibited and will cause disqualification. Multiple entries made through agents, third parties, organised groups or any entry duplication method will not be accepted. A maximum of one Prize may be won per participant.

Selection of winners

9. Within 4 weeks of the end of the Promotion Period, one (1) winner will be selected at random by Bestway using a computer-generated process within four (4) weeks of the Closing Date.

The Prize

10. The winner will receive a £5,000 cash prize (the “**Prize**”).
11. The Prize will be paid within eight (8) weeks of winner confirmation by BACS transfer to a UK bank account or via PayPal. The Fulfilment Provider will arrange prize fulfilment. Payments will only be made to UK bank accounts held with approved banks listed in Annex 1.
12. The Prize cannot be transferred. The Prize is non-transferable and non-refundable. There is no other alternative, except in circumstances outside the Promoter's control, where the Promoter has the discretion to replace the prize with an alternative of equal or higher value.

Winner Announcement and Delivery of the Prize

13. The winner will be contacted by Bestway using the contact details associated with their Bestway account within four (4) weeks of the Closing Date. The Fulfilment Provider will liaise with the winner to arrange fulfilment. If the winner does not respond within 14 days of the initial notification, their claim will become invalid and the Promoter reserves the right to offer the Prize to another eligible participant selected at random.
14. Participants who have not won will not be notified.

Data Protection and Marketing

15. By entering the Promotion, each participant agrees that any personal information provided by them may be held and used by Bestway, the Promoter, and the Fulfilment Provider (and their respective agents or suppliers) for the purpose of administering the Promotion and arranging fulfilment of the Prize. The Promoter may nevertheless disclose the information to the Advertising Standards Authority if required.

Limitation of Liability

18. Insofar as is permitted by law, the Promoter, Bestway, the Fulfilment Provider, their agents or distributors will not in any circumstances be responsible or liable to compensate the winner or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up the Prize except where it is caused by the negligence of the Promoter, Bestway, the Fulfilment Provider their agents or distributors or that of their employees. Your statutory rights are not affected.

General

26. The Promotion and these Terms are subject the laws of England and Wales. Any disputes must be referred to the English courts.
