### **The Parties**

1. Premier Foods Group Limited of Premier House, Centrium Business Park Griffiths Way, St. Albans, United Kingdom, AL1 2RE is the "**Promoter**".

2. Northern Confectioners Limited, 58 Old Eglish Road, Dungannon, Co. Tyrone, BT71 7PA, Northern Ireland is the “**Northern Confectioners**” and will be responsible for administering the Promotion and fulfilment of prizes.

### **Eligibility**

3. The Promotion is open to all retailers who are 18 years of age or older and hold a valid, active account with Northern Confectioners in Northern Ireland (“**Eligible Retailer**”). The Promotion is not open to employees, contractors, representatives, agents, officers or directors of the Promoter, its parent companies, subsidiaries, affiliates, marketing agencies, or to any of their immediate family members or persons living in the same household, whether or not related, or to anyone else professionally connected with the Promotion.
